Soudafoam FR HY is a one-component, self-expanding, ready to use PU-foam, which contains HCFC and CFC-free propellants who are not harmful for the ozone layer. Soudafoam FR HY is a PU-foam with fire retardant characteristics according to the European standard EN 1366-4.

### Properties:

- Fire resistant in a joint (EN 1366-4) for 240 minutes
- High filling capacity
- Good adhesion on all surfaces (except PE, PP and PTFE)
- High insulation, thermal and acoustic value
- Very good bonding properties
- Water resistant (not watertight)

### Shelf Life and Storage:

15 months unopened and stored in dry and cool conditions (Between +5°C and +25°C), upright storage is recommended.

Shake the aerosol can for at least 20 seconds. Put the adapter on the valve. Moisten surfaces with a water sprayer prior to application. For non-conventional substrates a preliminary adhesion test is recommended. Remove pressure from the applicator to stop. Fill holes and cavities for 1/3, as the foam will expand. Repeat shaking regularly during application. If you have to work in layers repeat moistening after each layer. Fresh foam can be removed using Soudal Gun & Foam cleaner or acetone. Prior to using the Gun & Foam cleaner, test whether surfaces are affected or not. Especially plastics and lacquer or paint layers can be sensitive to this. Cured foam can only be removed mechanically or with Soudal PU-Remover.

Surface temperature: +5°C to +35°C
