Description:

Soudal Swipex Hand Cleaner is a highly effective hand-cleaner with microgranules, specially designed to remove stubborn dirt from hands. Suitable for glue, silicone, polyurethane foam, paint and oil. Contains Sericin with moisturizing effect that keeps the skin soft.

Properties:

- Suitable for cleaning of hands
- Excellent cleaning properties
- Contains skin caring products
- Contains abrasive microgranules
- Not antibacterial

Applications:

It is ideal for removing residue stains from sealants, adhesives, and foams from hands.

Packaging:

Shelf life and Storage:

3 years in unopened packaging in a dry and cool environment at temperatures between +5°C and +25°C. To be used within 12 months from opening. The product may become cloudy or freeze partially at temperatures below 0°C. However, it will be usable after thawing.

Application method:

Put the needed quantity of product on the hands, rub till the complete emulsion of the dirt and rinse carefully. In order to best exploit the potential of the product it is recommended not to wet the hands neither before applying the handcleaner nor during the rubbing.

Health and Safety Recommendations:

In case of contact with eyes, wash immediately with plenty of water. Seek medical advice if the irritation persists. If ingested, rinse mouth thoroughly with running water. Avoid swallowing the product. Consult a doctor immediately.
